UNITED STATES TRADEMARK AND SERVICE MARK ASSIGNMENT

WHEREAS, **WEBCLICK CONCEPTS, INC.**, a corporation duly organized and existing under the laws of the State of Florida and having offices at 940 Lincoln Road, Suite 308, Miami Beach, FL 33139, United States of America, hereinafter referred to as "Seller," has adopted and used and is the owner of the trademarks and service marks set forth on Schedule A hereto in connection with the goods or services described therein (the "Marks"), together with the goodwill of the business in connection with which the Marks have been used (the "Goodwill"), and the applications for United States Trademark Registration set forth on Schedule A (the "Applications"); and

WHEREAS, **CIRCUIT CITY STORES, INC.**, is a corporation duly organized and existing under the laws of the Commonwealth of Virginia and having its principal office at 9950 Mayland Drive, Richmond, Virginia 23233, United States of America ("Purchaser"), and

WHEREAS, Seller and Purchaser are parties to an Asset Purchase and Sale Agreement (the "Agreement") dated as of June 29, 2005 among Purchaser, Seller, Nicolas Molina and Louis Olave (the latter two individuals, together, the "Shareholders"), pursuant to which Seller, together with the Shareholders, have agreed to sell and Purchaser has agreed to purchase certain assets including, without limitation, the Marks, together with the Goodwill, and the Applications.

NOW, THEREFORE, for the amount of One Dollar (U.S. \$1.00) and other good and valuable consideration as described in the Agreement, the receipt and sufficiency of which is hereby acknowledged, Seller has agreed to sell and has sold, assigned, transferred and set over, and by these presents does sell, assign, transfer and set over unto Purchaser and its successors and assigns Seller's entire right, title and interest in and to the Marks, the Goodwill and the Applications, to be held and enjoyed by Purchaser for its own use and benefit and for the use and benefit of its subsidiaries, successors, assigns and legal representatives, for the full extent of the life of the Marks and the term of any registrations issued based upon the Applications, to be used as fully and entirely as such rights would have been held and enjoyed by Seller had this Assignment and sale not been made.

Seller covenants that Seller is the owner of the Marks and the holder of record title to the Applications, that Seller has full power to make this Assignment and that Seller agrees to execute such further assignments and related documents with respect to the Marks, the Goodwill and the Applications as Purchaser shall reasonably request.

IN WITNESS WHEREOF, Seller has caused this Assignment to be executed by its proper officer thereunto duly authorized, the 8th day of July, 2005.

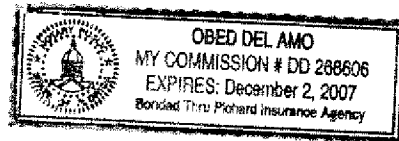
