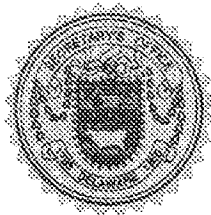

(a corporation without capital stock)**

Uniform Code Council, Inc. (the "Corporation"), a corporation organized and existing under and by virtue of the General Corporation Laws of the State of Delaware, DOES HEREBY CERTIFY:

FIRST: That at a meeting of the Board of Governors of Uniform Code Council, Inc., a resolution was duly adopted setting forth a proposed amendment to the Certificate of Incorporation of said corporation, declaring said amendment to be advisable and calling a meeting of the voting members of said corporation for consideration thereof. The resolution setting forth the proposed amendment is as follows:

**RESOLVED:**

1. The Voting Members of Uniform Code Council, Inc. approve and adopt the following amendment to the Certificate of Incorporation, to change its name to GSI US, Inc. (hereinafter the "Corporation") by changing the First Article thereof so that, as amended said Article shall be and read as follows: "1. Name. The name of the corporation is GSI US, INC."

2. The proper officers of the Corporation be, and they hereby are, authorized and directed to do any and all other acts and things as may be necessary, appropriate or desirable to facilitate the foregoing name change and otherwise to carry out the intent and purpose of the foregoing resolution.

SECOND: That thereafter, in lieu of a meeting and vote of the voting members, the voting members have given unanimous written consent to said amendment, dated May 6, 2005, in accordance with the provisions of Sections 228 and 242 of the General Corporation Law of the State of Delaware.
