

Such instruments and documents shall include, without limitation, affidavits of use, and other documents for filing in such jurisdictions as Assignee may from time to time reasonably request.

Assignor hereby represents and warrants that there are no rights and interests outstanding inconsistent with the rights and interests granted herein and that Assignor will not execute any instrument or grant or transfer any rights or interests inconsistent herewith.
