**RELEASE OF TRADEMARK COLLATERAL ASSIGNMENT  
AND  
REASSIGNMENT OF TRADEMARK**

This Release of Trademark Collateral Assignment and Reassignment of Trademark (the "Release") is made as of July 22, 2005, between **THE CIT GROUP/COMMERCIAL SERVICES, INC.**, a New York corporation ("Lender") and **BOXER HOLDINGS, INC.**, a California corporation ("Debtor").

WHEREAS, Borrower and Debtor entered into a certain Guaranty, dated \_\_\_\_\_, whereby Debtor guaranteed the obligations owing to Lender from Joe Boxer Corporation (the "Company") pursuant to a \_\_\_\_\_ Agreement, as amended (the "Agreement"); and

WHEREAS, the obligations of the Company to Lender under the Agreement were secured, in part, by an Intellectual Property Security Agreement dated on or about December 1, 2000, by and between Debtor, on the one hand, and Lender and BNP Paribas ("BNP"), as secured parties, and recorded December 8, 2000 ("Security Agreement"), in the Trademark records of the United States at Reel 2213, Frame 0827; and

WHEREAS, pursuant to an authorization letter from BNP's counsel dated on or about the date hereof, BNP granted Lender the right, authority and power to take all necessary action on BNP's behalf, to terminate and release BNP's security interest in Debtor's trademarks in accordance with this Release; and

WHEREAS, the obligations of Borrower to Lender secured by the trademarks have been satisfied;

NOW, THEREFORE, Lender, on its behalf, and on behalf of BNP, hereby releases its and BNP's security interests with respect to the Company's obligations to Lender and BNP under the Agreement, in the trademarks listed in the Agreement, attached hereto and incorporated herein, including any renewals thereof and all rights corresponding thereto, and reassigns to Borrower any and all rights in such trademarks held by Lender and/or BNP, without recourse, representation or warranty.

IN WITNESS WHEREOF, Lender has caused this Release of Trademark Collateral Assignment and Reassignment of Trademark with respect to its security interest in the trademarks which were collateral security for the Company's obligations to Lender, to be executed by its duly authorized representative as of the day and year first above written.

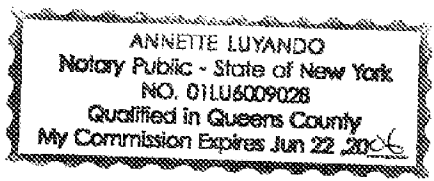
