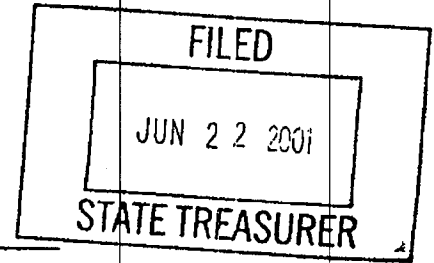

Pursuant to Section 14A:9-2  
of the Business Corporation Act  
of the State of New Jersey

Wilmar Industries, Inc., a New Jersey corporation (the "Corporation"),  
does hereby certify as follows:

1. Article 1 of the Corporation's Certificate of Incorporation is  
hereby amended to read in its entirety as set forth below:

"FIRST. The name of the corporation is INTERLINE BRANDS, INC."

2. Article 4, Section 1 of the Corporation's Certificate of  
Incorporation is hereby amended to read in its entirety as set forth below:

"1. Designation. The total number of shares of all classes of stock which the Corporation shall have authority to issue is 34,500,000; of which 7,500,000 shares, no par value per share, are to be of a class designated "Common Stock" (the "Common Stock") and 27,000,000 shares, par value \$.01 per share, are to be of a class designated Senior Preferred Stock (the "Senior Preferred Stock").

The rights, preferences, privileges and restrictions granted to and imposed upon the Common Stock are set forth below in this ARTICLE FOURTH. The rights, preferences, privileges and restrictions granted to and imposed upon the Senior Preferred Stock are set forth in the attached Exhibit A."

3. The amendment of the certificate of incorporation herein certified  
has been duly adopted and written consent has been given in accordance with the
