This Assignment made by and between Cushman Realty Corporation, a California corporation, located at P.O. 

NOW, THEREFORE, for good and valuable consideration, previously paid by Assignee to Assignor, the receipt of which is hereby acknowledged, Assignor does hereby sell, assign, set over and transfer to said Assignee, *nunc pro tunc*, as of December 31, 1993, the entire right, title and interest, including common law right, title and interest, in and to the aforesaid Assigned Trademark, and the aforesaid U.S. application for same, together with the whole of the goodwill of the business symbolized by said Assigned Trademark, the same to be held and enjoyed by the Assignee for its own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives, at common law and/or to the end of the term or

terms for which registration of the Assigned Trademark may be granted or renewed, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment and sale had not been made; together with all claims for damages by reason of past infringement of the Assigned Trademark with the right to sue for and collect the same for its own use and benefit, and for the use and on behalf of its successors, assigns or other legal representatives.

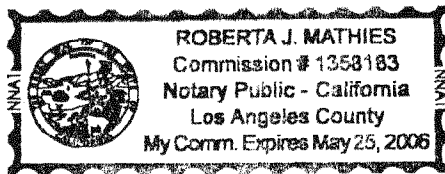
