DEED OF ASSIGNMENT OF TRADE MARKS made on Feb 28, 2005 (date)

BETWEEN

- (1) **ARLA FOODS** amba, a Danish company, of Skanderborgvej 277, 8260, Viby J, Denmark (the *Assignor*); and
- (2) **CREMO INGREDIENTS A/S**, a Danish company, of Toftegårdsvej 3, 5620 Glamsbjerg, Denmark (the *Assignee*).

WHEREAS

The Assignor is the proprietor of the trade mark registrations (the *Trade Marks*) and the applicant for the trade mark applications (the *Applications*) set out in Schedule 1.

The Assignor has agreed to sell and the Assignee has agreed to purchase the Trade Marks and the Applications.

IT IS AGREED as follows:

1. ASSIGNMENT

Assignor hereby assigns for good and valuable consideration, receipt of which is acknowledged to Assignee all right, title and interest in and to said Trade Marks and Applications and the above-named registrations and applications therefor, together with the goodwill of the business symbolized by said Trade Marks and Applications, including (without limitation):

- (a) all statutory and common law rights attaching to the Trademark Marks and the Applications; and
- (b) the right to sue for and obtain injunctive relief, damages and all other relief in respect of any infringement or misuse (whether past, present or future) of any of the Trade Marks, Applications or trade marks granted pursuant to any Application.

2. FURTHER ASSURANCE

The Assignor shall, at the request of the Assignee and at the Assignee's cost, execute all documents and do all things necessary to vest in the Assignee all rights assigned to the Assignee under this Deed of Assignment and to give the Assignee the full benefit of this Deed of Assignment.


