ASSIGNOR further assigns to and empowers Assignee, its successors, assigns or nominees, all rights to make and/or seek registrations, applications or other forms of protection for said Marks and to prosecute such registrations or applications and the Marks as well as to claim and receive the benefit of the Marks in the United States and/or elsewhere in the world, as Assignee shall decide in its sole discretion.

ASSIGNOR hereby releases and forever quitclaims to Assignee all of its right, title and interest in and to the Marks.

ASSIGNOR further covenants and agrees that Assignor will not execute any writing or do any act whatsoever conflicting with the terms of this assignment, and that it will at any time take such further action and to execute such documents as Assignee may reasonably request to effect, perfect or confirm the conveyance to Assignee of the Marks or enforcing any rights thereunder or related thereto.




