ASSIGNMENT NUNC PRO TUNC

WHEREAS, York International Corporation, a corporation organized under the laws of Delaware, having a place of business at 631 Richland Avenue, York, Pennsylvania, 17403 U.S.A. (hereinafter "Assignor"), was the owner of the trademark WATTMASTER in the United States along with U.S. Trademark Registration No. 1,310,490, for the mark WATTMASTER, registered in the Unites States Trademark Office (hereinafter "the Mark"); and

WHEREAS, Wattmaster Controls, Inc., a corporation organized under the laws of Kansas, having a place of business at 8500 NW River Park Dr., #108A, Parkville, Missouri, 64152 U.S.A. (hereinafter "Assignee"), acquired the Mark, but to date, a formal assignment document in a recordable form has not been executed

NOW, THEREFORE, for good and valuable consideration previously paid by Assignee to Assignor, the receipt and sufficiency of which hereby are acknowledged, Assignor and Assignee agree as follows:

Assignor hereby assigns to Assignee, *nunc pro tunc*, as of November 30, 1992, the entire right, title, and interest in and to the Mark, along with the goodwill associated therewith, the same to be held and enjoyed by the Assignee for its own use and enjoyment and for the use and enjoyment of its successors, assigns, or other legal representation. Assignor further assigns to Assignee, *nunc pro tunc*, all the right to sue for past, present, and future infringements, and all rights corresponding thereto throughout the world for the Mark.

This Assignment shall be binding upon the Parties, their successors and/or assignees, and all other acting by, through, with, or under their direction, and all those in privity therewith.


