**ARTICLES OF AMENDMENT OF  
ARTICLES OF INCORPORATION OF  
NEPTUNE INTERNATIONAL, LTD.**

These ARTICLES OF AMENDMENT of the Articles of Incorporation of Neptune International, Ltd. (the "Corporation") are executed pursuant to the provisions of RCW 23B.10.030 and 23B.10.060 as follows:

THIRD: This amendment does not provide for an exchange, reclassification or cancellation of issued shares.

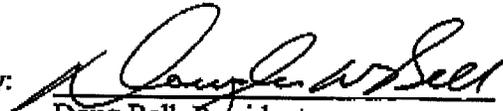
FOURTH: The date of the adoption of this amendment by the Director of the Corporation was March 18, 2005.
