RELEASE OF SECURITY INTEREST  
(Trademarks)

This RELEASE OF SECURITY INTEREST (the "Release") is made and entered into the 27th day of July, 2005, by and between Wells Fargo Foothill, Inc., a California corporation with an office located at One Boston Place, Boston, Massachusetts 02108, on behalf of itself and as agent for its affiliate group (collectively, the "Assignor") and Aluma Enterprises Inc., a Canadian corporation on behalf of itself and in conjunction with its affiliates and/or related entities with an office located at 4810 Dufferin Street, Toronto, Ontario, M3H 5S8 Canada (collectively, the "Assignee").

WITNESSETH

WHEREAS, to secure the complete and timely performance of certain obligations, Assignor and Assignee entered into a Trademark Security Agreement dated April 8, 2004 (the "Security Agreement") by which Assignor acquired a security interest in the trademarks, the respective trademark applications/registrations of Assignee as set forth on Schedule A attached hereto and by reference, incorporated herein, the goodwill of the business symbolized thereby and associated therewith and all license agreements ancillary thereto (collectively, the "Trademark Collateral");

WHEREAS, the Security Agreement was recorded on May 24, 2004 in the United States Patent and Trademark Office at Reel 3003/Frame 0894 to which reference may be had, the debt secured thereby having been paid and satisfied in full;

WHEREAS, Assignor desires to release any rights it may have acquired in the Trademark Collateral.

NOW, THEREFORE, in consideration of full payment and complete satisfaction of all obligations and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

1. Assignor hereby releases and conveys to Assignee, without recourse, representation or warranty of any kind, all of the Assignor's right, title and interest in and to the Trademark Collateral, whether currently existing or hereafter acquired or arising, including the Trademark Collateral listed on Schedule A.

2. Assignor, at no expense to itself, agrees to sign such further releases and assignments, and cooperate with the filing and recordation of this Release and such other releases and assignments, as is reasonably requested by Assignee to release any rights acquired by Assignor in the Trademark Collateral as a result of the Security Agreement, and any amendments, supplements or modifications thereto.
