- 5.3 the Assignor has not either by act or by omission caused or permitted anything which may endanger the registration of the Trade Marks;
- 5.4 the Assignor has not knowingly withheld from the Assignee knowledge of any circumstances that may cause the Registrar of Trade Marks to object to the registration of this Assignment;
- 5.5 the Assignor will keep the Assignee indemnified against all actions, claims, proceedings, costs and damages (including any damages or compensation paid by the Assignee on the advice of its legal advisers to compromise or settle any claim) and all legal costs or other expenses arising out of any breach of the above warranties or out of any claim by a third party based on any facts which if substantiated would constitute such a breach
