Assignor further agrees that it will take, or cause to be taken, all such further action as may reasonably be required by Assignor in order to effect the assignment contemplated hereby and to execute, verify, acknowledge and deliver all such further papers, including any instruments of transfer and recordable assignments, and perform such other acts as Assignee lawfully may request from time to time, to perfect and vest title in the Trademark in Assignee, or Assignee's successors and assigns.


