## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Release of Security Interest in Trademarks ("**Release**") is dated as of July 11, 2005. Reference is made to the Amended and Restated Supplemental Trademark Security Agreement, dated as of December 17, 2001 (as amended, restated, supplemented, or otherwise modified and in effect from time to time, the "**Grant**"), by and among American Restaurant Group, Inc., a Delaware corporation ("**ARG**"), ARG Enterprises, Inc., a California corporation ("**Enterprises**"), ARG Property Management Corporation, a California corporation ("**Property Management**"), ARG Terra, Inc., a Delaware corporation ("**Terra**"); ARG, Enterprises, Property Management, and Terra are collectively, jointly and severally, referred to as "**Assignor**", Wells Fargo Foothill, Inc., formerly known as Foothill Capital Corporation, a California corporation, and The Bank of New York Trust Company, N.A., formerly known as BNY Western Trust Company, as the collateral agent (the "**Assignee**") and recorded with the United States Patent and Trademark Office as Reel/Frame number 2430/0550.

Assignee hereby notifies, acknowledges to, and agrees with Assignor that, pursuant to the First Amended Joint Chapter 11 Plan of Reorganization of American Restaurant Group, Inc. and its Affiliated Debtors (Dated April 1, 2005), As Modified (the "Plan"), as confirmed by the Order Confirming First Amended Joint Chapter 11 Plan of Reorganization of American Restaurant Group, Inc., ARG Enterprises, Inc. and ARG Property Management Corporation (Dated April 1, 2005), As Modified, dated June 23, 2005 (the "Confirmation Order"), the security interest granted by Assignor in the collateral set forth in the Grant (the "**Trademark Collateral**") including, without limitation, in the Trademarks (as defined in the Grant) listed on the attached Schedule A, is terminated and released, and that Assignee hereby releases and forever discharges all of its right, title, and interest of any kind or nature granted, assigned, or conveyed pursuant to the Grant in the Trademark Collateral.

Assignee hereby releases all of its liens, pledges, security interests, charges, and other encumbrances of whatever nature (collectively, "**Encumbrances**") against Assignor created under the Grant.

Assignee hereby agrees, at the Assignor's sole cost and expense, to take such further actions and to execute and deliver such further documents as Assignor may reasonably request to effect and evidence this Release, including, without limitation, the execution and delivery of any filings, statements, amendments, recordings, or other instruments required to maintain the applications or registrations of the Trademark Collateral and record the chain of title accordingly with the United States Patent and Trademark Office, subject, in each case to Assignor's prior payment in full to Assignee of its costs and expenses (including reasonable fees and disbursements of counsel) incurred in connection therewith.


