ASSIGNMENT OF TRADEMARK

WHEREAS, FARMLAND INDUSTRIES, INC., a Kansas corporation having a principal place of business at 12200 N. Ambassador Drive, Kansas City, Missouri 64163 (hereinafter "ASSIGNOR") is the owner of the trademark ROCKY MOUNTAIN PRIDE and United States Registration No. 2,871,312 of said mark; and

WHEREAS, SF INVESTMENTS, INC., a Delaware corporation having a principal place of business at 3411 Silverside Road, 103 Baynard Building, Wilmington, Delaware 19810 (hereinafter "ASSIGNEE") acquired all of ASSIGNOR's rights, title and interest, and the goodwill symbolized thereby in various intellectual property pursuant to a Trademark Assignment agreement, dated October 28, 2003 (the "Agreement"), attached hereto as Exhibit A; and

WHEREAS, the trademark ROCKY MOUNTAIN PRIDE and United States Registration No. 2,871,312 was inadvertently omitted from the Agreement; and ASSIGNOR is desirous of making said acquisition of record.

NOW, THEREFORE, for and in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby mutually acknowledged, ASSIGNOR confirms that it sold, assigned, transferred and conveyed and does hereby sell, assign, transfer and convey to ASSIGNEE all rights, title and interest in and to the trademark ROCKY MOUNTAIN PRIDE, the goodwill symbolized thereby, and the United States Registration No. 2,871,312 of said mark, *nunc pro tunc* as of October 28, 2003.

The United States Patent and Trademark Office is hereby authorized to deliver to ASSIGNEE, its attorneys, agents, successors or assigns, all official documents and communications as may be warranted by this assignment.
