

**ASSIGNMENT OF TRADEMARK**

**THIS AGREEMENT**, made this 18<sup>th</sup> day of January, 2005 by and between Tempel Steel Company, an Illinois corporation, with an office at 5500 North Wolcott, Chicago, Illinois (hereinafter "Assignor") and The 5500 Corporation, an Illinois corporation, with an office at 5500 North Wolcott, Chicago, Illinois (hereinafter "Assignee").

**WHEREAS**, Assignor is the owner of the trademark and service mark registrations and applications as set forth on Exhibit A, attached hereto and made a part hereof (hereinafter collectively called the "Trademarks");

**WHEREAS**, Assignor desires to transfer the entire ownership of the Trademarks to Assignee;

(1) Assignor does hereby sell, assign and transfer to Assignee, its successors and assigns, throughout the United States and in all foreign countries: (a) all of Assignor's right, title and interest in and to the Trademarks, including all existing and future registrations of such trademarks and all renewals thereof; (b) the goodwill of Assignor's business in connection with which the Trademarks are used and which is symbolized by said Trademarks; (c) the right to claim all benefits and priority rights under any applicable convention; (d) all income, royalties, damages and payments now or hereafter due and/or payable under and with respect to the Trademarks, including, without limitation, payments under all licenses entered into in connection with the Trademarks and all damages and payments for past and future infringements; (d) the right to sue for past, present and future infringements of the Trademarks; and (e) all other rights and benefits corresponding to the Trademarks.

(2) Assignor, and any legal representative of Assignor, will assist the Assignee in the prosecution of any Trademark, and vesting in Assignee exclusive title to the same, including executing and delivering to Assignee any papers which may be requested by Assignee to carry out the terms of this Assignment.

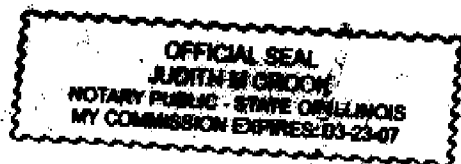

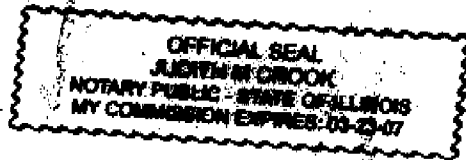
