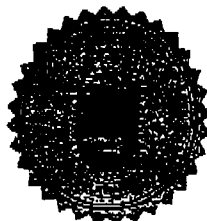

CORRECTING THE CERTIFICATE OF AMENDMENT OF THE AMENDED AND RESTATED CERTIFICATE OF INCORPORATION, FILED WITH THE DELAWARE SECRETARY OF STATE ON FEBRUARY 11, 2005.

Vallent Corp., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "Corporation"), certifies that:

A. The name of the Corporation, as currently reflected by the records of the Secretary of State of the State of Delaware, is Vallent Corp.

B. The original Certificate of Incorporation was filed with the Secretary of State of the State of Delaware on June 23, 1999 under the name WAC CORP. On July 16, 1999, the name of the Corporation was changed to WatchMark Corp. The Corporation's Amended and Restated Certificate of Incorporation was filed with the Delaware Secretary of State on November 17, 2004. The Certificate of Amendment of the Amended and Restated Certificate of Incorporation was filed with the Delaware Secretary of State on February 11, 2005 (the "Certificate"). The purpose of the Certificate was to change the name of the Corporation.

D. The inaccuracy or defect of the Certificate to be corrected is as follows:

The Certificate improperly stated that the Amended and Restated Certificate of Incorporation is amended to change the name of the Corporation to:

"Vallent Corp."

The Certificate is hereby corrected to state that the Amended and Restated Certificate of Incorporation is amended to change the name of the Corporation to:

"Vallent Corporation"

E. Pursuant to subsection (f) of Section 103 of the DGCL, the Certificate, as corrected by this Certificate of Correction, shall be effective as of February 11, 2005.

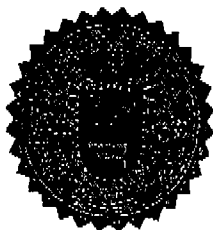
