ASSIGNMENT OF TRADEMARKS

WHEREAS, Assignor desires to assign and transfer to Assignee, and the successors, assigns, and legal representatives of the Assignee, the entire right, title, and interest in and to the Trademarks, the goodwill symbolized by the Trademarks and the registration thereof, as well as the right to sue for present, past, and future infringement, in the United States, its territorial possessions, and in all foreign countries, including all treaty and convention rights in and to the Trademarks.

NOW, THEREFORE, for the foregoing recited consideration and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby assign, sell, and transfer to Assignee all of its right, title, and interest in and to the Trademarks, the goodwill symbolized by the Trademarks and the registration thereof, and any legal equivalent thereof in a foreign country, including any applications, renewals, and extensions thereof. Assignor does further consent to the recordation of this Assignment by Assignee with the United States Commissioner of Patents and Trademarks or any similar foreign government agency.
