1. The name of the Corporation is Welbilt Corporation and the original Certificate of Incorporation of the Corporation was filed with the Secretary of State of the State of Delaware on March 20, 1987.

2. The Certificate of Incorporation of the Corporation is hereby amended by deleting paragraph FIRST in its entirety and substituting in lieu and in place thereof the following:

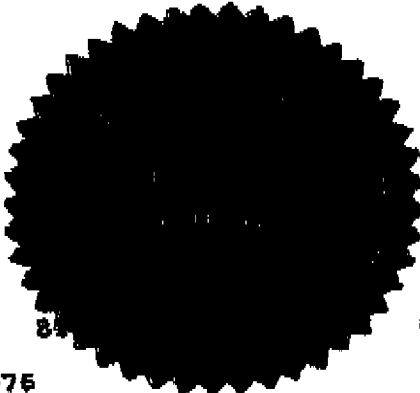
