CONFIRMATORY ASSIGNMENT OF TRADEMARKS



Leblanc Corporation, a Wisconsin corporation ("Assignor"), is made pursuant to, and effective from, an Asset Purchase Agreement, dated July 22, 2004, entered into by and between Assignor and Steinway Musical Instruments, Inc., a Delaware corporation ("SMI").

Assignor, which adopted and used the trademark OPUS, and secured a registration thereof in the U.S. Patent and Trademark Office, Registration No. 1,776,453 granted June 15, 1993 (hereinafter referred to as "the Mark"), for the foregoing recited consideration and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, does hereby confirm and assign to Conn-Selmer, Inc., a Delaware corporation having a place of business at 600 Industrial Parkway, Elkhart, Indiana 46515 ("Assignee"), as successor in interest to Leblanc, Inc., a Delaware corporation (formerly Soprano II, Inc., a Delaware corporation, which was a successor in interest to SMI), all right, title and interest in and to the Mark, together with the good will of the business symbolized by the Mark, effective as of the date hereof. Assignor does hereby further confirm and assign to Assignee any and all causes of action, claims, demands, or other rights occasioned from or because of any and all past infringements of said Mark, together with the right in Assignee to sue and recover therefore, including the right to bring suit in its own name.
