Pursuant to the provisions of Sections 14A:9-2(4) and 14A:9-4(3) of the *New Jersey Business Corporation Act*, the undersigned corporation executes the following Certificate of Amendment to its Certificate of Incorporation:

1. The name of the corporation is: The Spencer Organization, Inc. (the "Corporation").
2. The following amendments to the Certificate of Incorporation were approved by the Directors and thereafter duly adopted by the shareholders of the Corporation on the 5<sup>th</sup> day of August, 1998:

RESOLVED, that "Paragraph THIRD" of the Certificate of Incorporation is hereby replaced with the following provision:

"Paragraph THIRD: The aggregate number of shares which the Corporation shall have the authority to issue is hereby increased to Ten Million (10,000,000) shares, all of which are no par value and of the same class."

RESOLVED, that "Paragraph FIRST" of the Certificate of Incorporation is hereby replaced with the following provision:

"Paragraph FIRST: The name of the corporation is Planet Associates, Inc."

3. The number of shares outstanding at the time of the adoption of the amendment was: One Hundred (100). The total number of shares entitled to vote thereon was One Hundred (100).

4. The number of shares voting for and against such amendment are as follows:

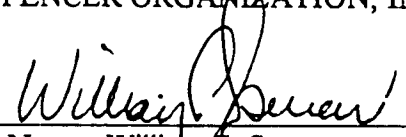
5. The effective date of this Amendment to the Certificate of Incorporation shall be as of the date it is filed with the Secretary of State of the State of New Jersey.
