NUNC PRO TUNC TRADEMARK ASSIGNMENT

THIS ASSIGNMENT is entered into **Nunc Pro Tunc** effective as of December 31, 1997, and is made by and between **DR. SOLOMON'S SOFTWARE, INC.**, a Massachusetts corporation ("Assignor"), and **MCAFEE, INC.**, a Delaware corporation with a place of business in the State of California ("Assignee").

WHEREAS, Assignor is the owner of all right, title and interest in and to the trademark **VIREX** and its U.S. Trademark Registration No. 1,548,110 (the "Trademark"); and

WHEREAS, Assignee is desirous of acquiring the entire right, title and interest of Assignor in and to the Trademark along with the goodwill of the business symbolized by the Trademark and all other rights appurtenant thereto.

NOW, THEREFORE, for and in consideration of the mutual covenants and agreements contained herein and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby sell, assign, transfer and deliver to Assignee, its successors, assigns and legal representatives, its full and exclusive right, title and interest in and to the Trademark, together with the goodwill of the business symbolized by the Trademark and associated therewith, and all other common law rights, and the right to recover for damages and profits for past infringements of the Trademark. Said assignment specifically includes all right, title and interest in and to U.S. Trademark Registration No. 1,548,110.

This assignment shall be binding upon Assignor's successors, assigns and legal representatives, and shall inure to the benefit of Assignee, its successors, assigns and legal representative, as the case may be.
