# RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL

This RELEASE, dated as of August 5, 2005, is made by GENERAL ELECTRIC CAPITAL CORPORATION, a Delaware banking corporation (in such capacity, the "Collateral Agent"), as successor to THE BANK OF NOVA SCOTIA (in such capacity, the "Former Collateral Agent"), pursuant to the termination of the Amended and Restated Credit and Guaranty Agreement, dated as of August 29, 2003 (as amended, amended and restated, supplemented or otherwise modified, the "Credit Agreement"), by and among IPC ACQUISITION CORP., a Delaware corporation ("Company"), the Collateral Agent, certain of its subsidiaries (collectively, with the Company, the "Grantors"), and other agents and lenders party thereto.

#### WITNESSETH

WHEREAS, pursuant to the Pledge and Security Agreement (the "Security Agreement"), dated as of December 20, 2001, by and among the Grantors and the Former Collateral Agent, and recorded with the U.S. Patent and Trademark Office on January 24, 2002 at Reel/Frame Nos. 12559/0446 and 2443/0356, the Grantors granted the Collateral Agent a security interest in and to all of its right, title and interest in, to and under all of its patents, trademarks, and copyrights, and all goodwill associated with such intellectual property, and all proceeds of any and all of the foregoing;

WHEREAS, pursuant to the Amended and Restated Pledge and Security Agreement (the "Amended Security Agreement"), dated as of August 29, 2003, by and among the Grantors and the Collateral Agent, and recorded with the U.S. Patent and Trademark Office on September 4, 2003 at Reel/Frame Nos. 13943/0570 and 2712/0082 and with the U.S. Copyright Office on September 10, 2003 at V3501 P805, the Grantors granted the Collateral Agent a security interest in and to all of its right, title and interest in, to and under all of its patents, trademarks, and copyrights, and all goodwill associated with such intellectual property, and all proceeds of any and all of the foregoing;

WHEREAS, the Collateral Agent acknowledges full payment, complete performance and satisfaction of all obligations pursuant to the Security Agreement and the Amended Security Agreement have been made;

WHEREAS, the Grantors have requested that the Collateral Agent release its security interest in its patents, trademarks, copyrights, and other intellectual or industrial property, whether registered or not and whether under license or otherwise, as defined in the Security Agreement in connection with the termination of the Credit Agreement (the "Released Collateral").

NOW, THEREFORE, in consideration of the foregoing, the Collateral Agent hereby RELEASES, without recourse, all of its security interest in the patents, trademarks, and
