## **ASSIGNMENT OF SERVICE MARK**

Assignor hereby binds itself, its heirs, legal representatives, administrators and assigns properly to cooperate in the Assignee's recordation of title, maintenance and protection of said Service Mark, and to execute, without any further consideration or remuneration, any and all applications, petitions, oaths and assignments or other papers and instruments which may be necessary in order to carry into full force and effect the sale, assignment, transfer and conveyance hereby made or intended to be made, and to communicate to said Assignee or its representatives and assigns all facts known to the undersigned respecting said Service Mark, whenever requested, and to testify in any interference proceeding or other legal proceedings in which said Service Mark, or any other service mark owned by Assignor may be at issue.

The Commissioner of Patents and Trademarks is hereby requested to record this Assignment of the Service Mark to the Assignee.
