#### TRADEMARK AND COPYRIGHT ASSIGNMENT

WHEREAS, the Buyer wishes to purchase, acquire and accept from the Assignor, and the Assignor wishes to sell, transfer, assign and deliver to the Buyer, all of the Assignor's right, title and interest in, to and under the Marks and the Works, including any rights the Assignor may have acquired by assignment.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto hereby agree as follows:

- 1. The Assignor hereby sells, conveys, assigns, transfers and delivers to the Buyer all of the Assignor's right, title, and interest in, to and under the Marks and the Works, together with the goodwill associated therewith, including all applications and registrations therefor. The Assignor further sells, conveys, assigns, transfers and delivers to the Buyer any and all causes of action arising under the rights assigned hereunder that may have arisen prior to the date hereof. The Assignor further sells, conveys, assigns, transfers and delivers to the Buyer all proceeds to infringement suits, the right to sue for past, present and future infringements, and all rights corresponding thereto throughout the world for all of the rights herein assigned.
- 2. The Assignor agrees to execute and deliver at a future date any additional documents that Buyer reasonably determines are required under federal or state law, to perfect the Buyer's ownership of any intellectual property rights in the Marks or the Works. The Assignor will not file any applications for trademark registration in the U.S. Patent and

Trademark Office or its foreign counterparts for the Marks or any copyright registration in the U.S. Copyright Office or its foreign counterpart for the Works.

- 3. This Assignment will apply to, be binding in all respects upon and inure to the benefit of the successors and permitted assigns of the parties. Nothing expressed or referred to in this Agreement will be construed to give any Person other than the parties to this Agreement any legal or equitable right, remedy or claim under or with respect to this Agreement or any provision of this Agreement, except such rights as shall inure to a successor or permitted assignee pursuant to this Section 3.
- 4. This Assignment will be governed by and construed under the laws of the State of California without regard to conflicts-of-laws principles that would require the application of any other law.
- 5. This Assignment may not be amended, supplemented, or otherwise modified except by a written agreement executed by the party to be charged with the amendment.
- 6. This Assignment may be executed in one or more counterparts, each of which will be deemed to be an original copy of this Assignment and all of which, when taken together, will be deemed to constitute one and the same document. The exchange of copies of this Assignment and of signature pages by facsimile transmission shall constitute effective execution and delivery of this Assignment as to the parties and may be used in lieu of the original Assignment for all purposes.
