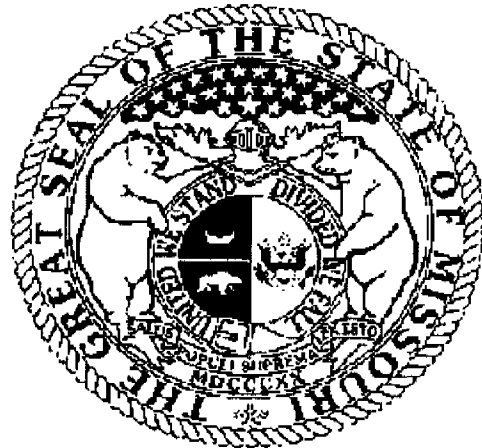

## SUMMARY ARTICLES OF MERGER

State of Missouri

Pursuant to the provisions of The General and Business Corporation Law of Missouri (the "Act"), the undersigned corporations certify the following:

1. **NAME OF CONSTITUENT CORPORATIONS.** TUFF-N-NUFF U.S.A., INC. (a Missouri corporation); GREENSTREAK, INC. (a Missouri corporation); WESTEC BARRIER TECHNOLOGIES INC. (a Missouri corporation) (each of which are herein, collectively, called "Subsidiary Corporations"), are hereby merged with and into WESTERN PLASTICS, INC. (a Missouri corporation) (herein called the "Surviving Corporation").
2. **APPROVAL.** A plan of merger has been adopted pursuant to §351.430 of the Act.
3. **RESOLUTION.** Such plan of merger was adopted by the board of directors of the Surviving Corporation on December 17, 2004. The Surviving Corporation owns 100% of the issued and outstanding shares of capital stock of each of the Subsidiary Corporations and, therefore, the Surviving Corporation is in compliance with the ninety percent ownership requirement of §351.447 of the Act and the Surviving Corporation will maintain at least ninety percent ownership until the issuance of the certificate of merger by the secretary of state.
4. **EFFECTIVE DATE.** Pursuant to the Plan of Merger, the effective date of the Merger is January 2, 2005.
5. **NAME.** The name of the surviving corporation is Western Plastics, Inc.
6. **ARTICLES OF INCORPORATION.** The Articles of Incorporation of Surviving Corporation on the Effective Date shall continue to be the Articles of Incorporation of the Surviving Corporation; provided, however, that Article I of the Articles of Incorporation of the Surviving Corporation is amended to read as follows:  

The name of the corporation is Greenstreak Group, Inc.
7. **PLAN OF MERGER.** The executed plan of merger is on file at the principal place of business of the Surviving Corporation: 3400 Tree Court Industrial Boulevard, St. Louis, MO 63122. The Plan of Merger adopted the name change described above in accord with §351.447 of the Act.
8. **COPY.** A copy of the Plan of Merger will be furnished by the Surviving Corporation on request and without cost, to any shareholder of any corporation that is a party to the merger.
