**TRADEMARK RELEASE AGREEMENT AND RELEASE OF
COLLATERAL ASSIGNMENT OF TRADEMARKS**

THIS TRADEMARK RELEASE AGREEMENT AND RELEASE OF COLLATERAL ASSIGNMENT OF TRADEMARKS (this "Agreement") is made as of September 30, 1997, from SUMMIT BANK (successor by merger to United Jersey Bank), as agent ("Releasor"), having an address at 210 Main Street, Hackensack, New Jersey 07601 to CONSOLIDATED DELIVERY & LOGISTICS, INC. ("Borrower"), having an address at 380 Allwood Avenue, Clifton, New Jersey 07012, and AMERICAN COURIER, INC., CLICK MESSENGER SERVICE, INC., DISTRIBUTION SOLUTIONS INTERNATIONAL, INC., COURT COURIER SYSTEMS, INC., SILVER STAR EXPRESS, INC. (for itself, and as successor by merger to Crown-Bestway Corp.), CLAYTON/NATIONAL COURIER SYSTEMS, INC., SUREWAY LOGISTICS CORPORATION, NATIONAL EXPRESS COMPANY, INC., OLYMPIC COURIER SYSTEMS, INC., SECURITIES COURIER CORPORATION, CLICK MESSENGER SERVICE OF N.Y., INC. AND SUREWAY AIR TRAFFIC CORPORATION (collectively, the "Subsidiary Borrowers"), each having an address c/o the Borrower at 380 Allwood Avenue, Clifton, New Jersey 07012.

BACKGROUND

On or about May 31, 1996, the Borrower and the Subsidiary Borrowers entered into a Memorandum of Collateral Assignment of Trademarks with the Releasor to induce the Releasor and the other banks to make loans to the Borrower and the Subsidiary Borrowers under a credit agreement. As security for the repayment of such loans, the Borrower and the Subsidiary Borrowers granted a security interest and collateral assignment in certain trademarks listed on Exhibit "A" attached hereto, incorporated herein, and made a part hereof (the "Trademarks") to Releasor, which was recorded on June 11, 1996 by the Assignment Division of the U.S. Patent and Trademark Office on Trademark Reel 1510, Frame 0484. The indebtedness secured by the Trademarks has been fully paid and satisfied and Releasor has agreed to release its security interest and collateral assignment in the Trademarks.


NOW, THEREFORE, Releasor, intending to be legally bound hereby and for good and valuable consideration, covenants and agrees as follows:

Releasor hereby unconditionally and absolutely discharges and releases all of its right, title and interest in and to the Trademarks, including, without limitation, the collateral assignment of the Trademarks granted as of May 31, 1996 to Releasor by the Borrower and the Subsidiary Borrowers. From and after this date, Releasor shall have no further interest in the Trademarks.
