

ASSIGNMENT OF TRADEMARK

This Assignment having an effective date of March 9, 2005, is made by and between Spang & Company, a Pennsylvania corporation, located and doing business at 111 Zeta Drive, P.O. Box 11422, Pittsburgh, Pennsylvania 15238 ("Assignor") and Magnetic Shield Corporation, an Illinois corporation, located and doing business at 740 North Thomas Drive, Bensenville, IL 60106 ("Assignee").

WHEREAS, Assignor owns the trademark listed on Exhibit A attached hereto (the "Mark"), and

WHEREAS, this Mark is registered in the U.S. Patent and Trademark Office as noted on Exhibit A, and

WHEREAS, Assignee wishes to acquire the Mark and any registrations thereof

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, the receipt of which is hereby acknowledged, Assignor hereby sells, assigns and transfers to Assignee, its successors and assigns, all of its right, title and interest in and to the Mark (subject to that certain license agreement previously granted by Assignor providing a royalty free non-exclusive license granted to Allegheny Ludlum Steel Corporation effective as of June 1, 1983, a copy of which is attached as Exhibit B), all registrations of the Mark, together with that part of the good will of the business connected with the use of and symbolized by the Marks, and including Assignor's entire right, title and interest in and to any and all causes of action and rights of recovery for past infringement of the Mark. Assignor hereby represents and covenants that it has full right to convey the entire interest herein assigned; except as indicated above, it has not executed, and will not execute, any agreements inconsistent herewith; and the information as set forth on Exhibit A is accurate.

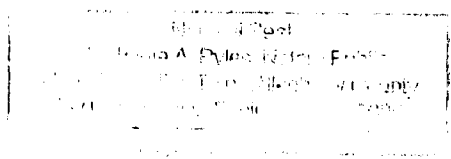
