RELEASE OF SECURITY INTERESTS IN PATENTS AND TRADEMARKS

This Release of Security Interests in Patents and Trademarks is granted and conveyed as of April 1, 2005, 2005, by Baltic Sea Limited ("Baltic Sea"), having an office at 8th Floor, Henley Building, 5 Queen's Road, Central, Hong Kong, in favor of Money's Foods U.S., Inc. ("Money's"), a U.S. corporation, having its principle business address at P.O. Box 351, P152 County Road 12, Napoleon, OH 43545-0351.

WHEREAS, Vlastic Farms, Inc. and Montreal Trust Company of Canada, as Trustee, ("Montreal Trust") entered into a Security Agreement dated as of January 31, 2000, and a Trademark Security Agreement dated as of January 31, 2000, (the "Agreements"), under which Money's granted to Montreal Trust a security interest in the U.S. patents and U.S. Federal trademark registrations listed on the attached Schedule A, including any and all applications or registrations therefor, and the goodwill associated with the trademarks (the "Patents and Trademarks").

WHEREAS, Vlastic Farm, Inc. and Money's Foods (U.S.) Ltd. merged pursuant to an Agreement of Merger dated as of February 1, 2000, thereby forming Money's.


WHEREAS, Baltic Sea is the assignee of the security interest of the Patents and Trademarks held in favor of Montreal Trust as evidenced by the document attached as Exhibit 1.

WHEREAS, Money's has satisfied some of its outstanding obligations under the Security Agreement, and the parties seek to make a record of Baltic Sea's release and reassignment to Money's of any and all of their security interests in the Patents and Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which the parties acknowledge, Baltic Sea (1) releases, discharges and relinquishes, as of April 1, 2005, its security interests in any and all of the IP, including the Patents and Trademarks, and (2) reassigns to Money's, as of April 1, 2005, all right title, and interest that it may have had in any and all of the IP, including the Patents and Trademarks listed on Schedule A, including any and all applications or registrations therefor, and the goodwill associated with the Trademarks, and the right to sue for past, present and future infringements, and the proceeds thereof, including, without limitation, license royalties and proceeds of infringement suits. Baltic Sea and its predecessors in interest specifically acknowledge that the Security Agreement is no longer effective, and that it does not own any rights to or have any ownership interest in any and all of the IP, including the Patents and Trademarks listed in Schedule A, and all of the rights and remedies with respect to any and all of the IP, including the Patents and Trademarks have been and are hereby extinguished.

Nothing contained in this Release of Collateral shall be construed as a waiver by Baltic Sea of any claim it has against Money's or against any other collateral given by Money's to secure the balance of its indebtedness to Baltic Sea.
