
CERTIFICATE OF AMENDMENT

UNDER SECTION 805 OF THE BUSINESS CORPORATION LAW

- 1. The name of the corporation is Detection Systems Inc.
- 2. The certificate of incorporation of said corporation was filed by the Department of State of the State of New York on the July 11, 1968.
- 3. (a) The certificate of incorporation is amended to provide for the change of the corporation's name.

(b) To effect the foregoing, Article One is amended to read as follows: The name of the corporation is BOSCH SECURITY SYSTEMS, INC.
