THIRD: The name of the surviving limited liability company is Revolution LLC.

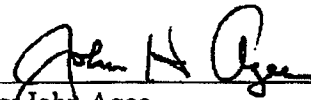
FOURTH: The merger is to become effective immediately upon filing of this Certificate of Merger.
