IN WITNESS WHEREOF, Secured Party, by its duly authorized officer, has executed this Release on this 12th day of August, 2005.

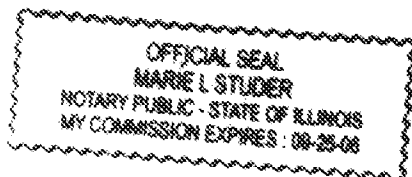
