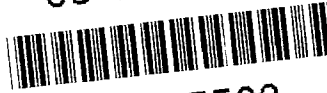


WHEREAS, the Security Agreement was recorded in the United States Patent and Trademark Office on April 2, 1998, at Reel 1710, Frame 0629; and

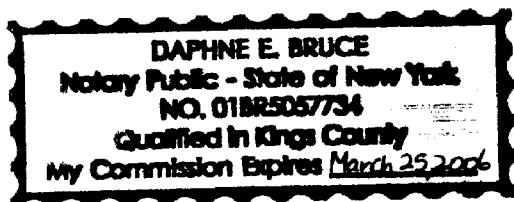
