In accordance with the provisions of a draft partial contribution of business assets approved by a joint general ordinary and extraordinary meeting of 15 September 2004, AIR FRANCE - KLM made contribution, as a partial contribution of business assets, under the rules of demergers, with retroactive effect to 1 April 2004, to société Air France (N° 420495178) of all its assets and liabilities, in particular the property, rights and obligations attached to the carried on business of airline transport consisting more especially in the transport of passengers on domestic and international flights, air freight, aeronautic maintenance and any other operation which may be related directly or indirectly to this business.

Within this framework, the intangible fixed assets of AIR FRANCE - KLM were transferred to société Air France (N° 420495178), said intangible fixed assets including the trademarks and designs held by the company.

The partial transfer of business assets agreement including many other provisions, it was agreed between the parties that the purpose of the present agreement is to allow the recordal in the concerned national Registers of the transfer of ownership to société Air France (N° 420495178) of all the trademarks and designs concerned by the partial transfer of business assets, that is to say all the industrial property rights which were held by the company AIR FRANCE - KLM.

For this purpose, AIR FRANCE - KLM confirms having transferred in full ownership to société Air France (N° 420495178) all the trademarks and designs enumerated in the hereto attached schedule, along with the goodwill of the business in which the trademarks are used, it being specified that, for the trademarks, all of the goods and services claimed by every transferred trademark are concerned.


Société Air France (N° 420495178) approved the partial transfer of business assets with AIR FRANCE - KLM during a joint general ordinary and extraordinary meeting of 15 September 2004.

Full powers are hereby granted to a bearer of the present agreement for the purpose of carrying out its recordal in the National Trademarks Register and the National Designs Register held by the Industrial Property Office.
