TRADEMARK ASSIGNMENT

THIS ASSIGNMENT, dated as of August 16, 2005 (the "Assignment"), is made by Cathy J. Boaz, an individual domiciled in the state of Indiana, with an address of 6028 Rosslyn, Indianapolis, Indiana 46220 ("Assignor") and Platypus Wear Inc., a California corporation located and doing business at 501 West Broadway, Suite 2020 San Diego CALIFORNIA 92101 ("Assignee").

Recitals

WHEREAS, Assignor and Assignee are parties to a certain Settlement Agreement effective August 16, 2005 (the "Settlement Agreement");

WHEREAS, Assignor has sought registration of the mark BAD GIRL & COMPANY with the United States Patent & Trademark Office and owns application serial no. 78/082,333 for the same (the "Trademark"); and

WHEREAS, Assignor has agreed pursuant to the Settlement Agreement to sell, assign, transfer and convey to Assignee all right, title and interest in and to the Trademark, including the application therefor, and the goodwill associated with the Trademark, as part of the entire business or portion therefor to which the Trademark pertains.

Agreement

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby takes the following actions and makes the following agreement:

A. Assignment of Rights. Assignor hereby irrevocably transfers and assigns to Assignee all right, title, and interest (of any nature, in any form, market, or media, whether or not currently in existence) throughout the universe in perpetuity, in and to the Trademark. Assignor makes the foregoing transfer and assignment to the full extent now or hereafter permitted by the laws of the United States of America or the laws of any other countries, without condition, limitation, or reservation, including but not limited to: all trademark rights and goodwill appurtenant thereto; any related common law or statutory rights associated with the Trademark; the right to sue for and to collect damages, profits and other relief for any past, present and future infringement of the Trademark.


