## RELEASE OF TRADEMARK SECURITY AGREEMENT

**WHEREAS**, G-III Leather Fashions, Inc., a New York corporation (“**G-III Leather**”), is a party to that certain Loan Agreement dated as of October 29, 1992, by and among G-III Leather and the banks signatory thereto (the “**Banks**”), as amended, modified or supplemented from time to time (the “**Loan Agreement**”), and

**WHEREAS**, in connection with the Loan Agreement G-III Leather entered into that certain Trademark Security Agreement, as amended, modified and supplemented from time to time (the “**Trademark Security Agreement**”), with G-III Apparel Group, Ltd., a Delaware corporation, (“**G-III**”), Siena Leather Ltd., a New York corporation (“**Siena**” and collectively with G-III and G-III Leather, the “**Debtors**”), and Bank of America, N.A., successor by merger to Fleet National Bank (successor in interest to National Westminster Bank U.S.A.) (such entities are collectively, the “**Secured Party**”),

**WHEREAS**, the Debtors granted security interests in all right, title and interest in and to certain trademarks, including the trademarks listed on Schedule 1 attached hereto (such listed trademarks are the “**Trademarks**”), to the Secured Party, for the ratable benefit of the Banks, and

**WHEREAS**, the security interests granted pursuant to the Trademark Security Agreement with respect to the Trademarks, were recorded in the United States Patent and Trademark Office on November 9, 1992 at Reel/Frame 0901/0684.


**NOW THEREFORE**, for good and valuable consideration, the Secured Party does hereby absolutely and unconditionally release and forever discharge any and all security interests, mortgages and other interest in any intellectual property granted by the Debtors, or an affiliate of Debtors, pursuant to the Trademark Security Agreement, specifically including, but not limited to, the Trademarks listed on Schedule 1 attached hereto. The Secured Party further

absolutely and unconditionally releases all of its right, title and interest in and to any and all property, assets and collateral secured, hypothecated or pledged under or by the Trademark Security Agreement.

Bank of America, N.A., a national banking association, as successor by merger to Fleet National Bank (successor in interest to National Westminster Bank U.S.A.), expressly acknowledges and affirms that upon execution hereof, it shall have no rights and remedies with respect to the Trademarks or other intellectual property of Debtors and their affiliates.
