CERTIFICATE OF INCORPORATION**

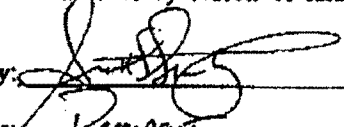

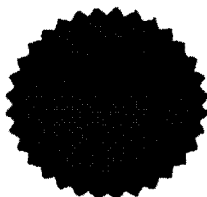
