WHEREAS, Assignee now desires to acquire all of Assignor's entire right, title and interest in and to the Mark; and



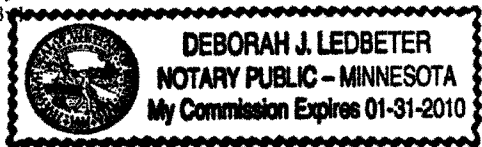
