REASSIGNMENT AND FULL RELEASE OF SECURITY INTEREST

This Reassignment and Full Release of Security Interest is made as of October 24, 2004 by COMERICA BANK, successor by merger to Imperial Bank ("Lender") to Where International, L.P., a Delaware limited partnership, with its principal place of business at 11100 Santa Monica Blvd., Los Angeles, California 90025 ("Grantor").

Recitals

Now therefore, Lender agrees that it releases and discharges its security interest in the Trademarks and reassigns to Grantor, without warranty or recourse, all interest of Lender in and to the Trademarks.
