WHEREAS, Trade Products Associates, a Washington limited partnership, having its principal place of business at P.O. WHEREAS, on January 18, 1990, Assignor filed an application to register the service mark PACK-RAT MINI-STORAGE AND DESIGN in the United States Patent and Trademark Office and assigned Serial No. 74/020,195, which application issued on April 16, 1991 as U.S. Registration No. 1,641,569;

WHEREAS, on January 16, 1990, Assignor filed an application to register the service mark PACK RAT in the United States Patent and Trademark Office and assigned Serial No. 74/019,020, which application issued on March 15, 1991 as U.S. Registration No. 1,637,144;

WHEREAS, Assignor claims to own the entire right, title and interest in and to the service marks PACK-RAT MINI-STORAGE AND DESIGN and PACK RAT, including the common law rights arising from Assignor's use of such marks in commerce in the United States, as well as all rights in and to the United States service mark applications and registrations relating to such marks and the goodwill of the businesses associated therewith;
