This Assignment is given pursuant to the Trademark Purchase And Sale Agreement dated May 23, 2005 between Assignor and Assignee and is subject to the terms thereof, and shall not be construed to limit, alter, impair, enhance or enlarge the rights and obligations of Assignee and Assignor thereunder and is given solely for purposes of separately evidencing the transactions contemplated thereby.
