SCHEDULE B TO AUTHENTICATED DEMAND**RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

This Release of Security Interest in Intellectual Property ("Release") is dated as of June 10, 2005. Reference is hereby made to that certain Security Agreement (as amended, restated, supplemented or otherwise modified and in effect from time to time, the "Grant"), dated as of January 31, 1996 between Hawaiian Airlines, Inc. Assignee hereby notifies, acknowledges to and agrees with Assignor that the security interest granted by Assignor in the collateral set forth in the Grant (the "Intellectual Property Collateral") including, without limitation, in the Intellectual Property Collateral (as defined in the Grant) listed on the attached Schedule A, is terminated and released, and that Assignee hereby releases and forever discharges all of its right, title and interest of any kind or nature granted, assigned or conveyed pursuant to the Grant in the Intellectual Property Collateral.



Assignee hereby agrees, at the Assignor's sole cost and expense, to take such further actions and to execute and deliver such further documents as Assignor may reasonably request to effect and evidence this Release, including, without limitation, the execution and delivery of any filings, statements, amendments, recordations or other instruments required to maintain the applications or registrations of the Intellectual Property Collateral and record the chain of title accordingly with the United States Patent and Trademark Office, subject, in each case to Assignor's prior payment in full to Assignee of its costs and expenses (including reasonable fees and disbursements of counsel) incurred in connection therewith; provided, however, that Assignee shall not be required to take any action which Assignee reasonably determines could expose Assignee to liability or which is contrary to applicable law.
