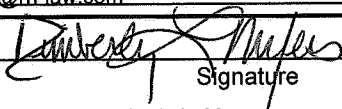

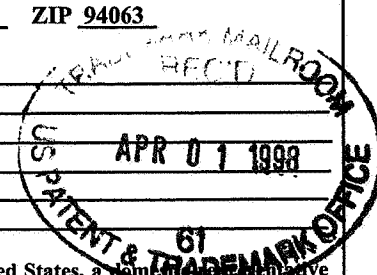

ARTICLES OF INCORPORATION**

Jerry Chang and Michael Vargo hereby certify that:

ONE: They are the duly elected President and Secretary, respectively, of NetiPhone, Inc., a California corporation (the "Company").

TWO: Article I of the Company's Articles of Incorporation is amended to read in its entirety as follows:

"I.

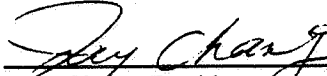
The name of the Corporation is Clarent Corporation (the "Corporation" or the "Company")."


THREE: The foregoing amendment of the Articles of Incorporation has been duly approved by the Board of Directors of the Company.

FOUR: The foregoing amendment of the Articles of Incorporation has been duly approved by the required vote of shareholders in accordance with section 902 of the California Corporations Code. The Corporation has two classes of stock outstanding, which are entitled to vote together as a single class with respect to the amendment herein set forth. The total number of outstanding shares of the Corporation is Twenty One Million (21,000,000) shares, which consists of Fifteen Million (15,000,000) shares of Common Stock and Six Million (6,000,000) shares of Preferred Stock. The total number of outstanding shares entitled to vote with respect to the foregoing amendment is Three Million Seven Hundred Thousand (3,700,000) shares of Common Stock, One Million (1,000,000) shares of Series A Preferred stock, and Two Million Eight Hundred Twenty Thousand (2,820,000) shares of Series B Preferred stock. The total number of shares voting in favor of the amendment was more than fifty percent (50%) of the outstanding shares of the Corporation.
