FIRST: That this corporation was incorporated on the 21st day of June, 1968, pursuant to the General Corporation Law of the State of Delaware.

SECOND: That this corporation owns all of the outstanding shares of each class of the stock of LURIA BROTHERS & COMPANY, INC., a corporation incorporated on the 2nd day of December, 1964, pursuant to the General Corporation Law of the State of Delaware.
