- (2) Without limiting the generality of the foregoing the assignment includes the right to pursue the prosecution of the Applications through to registration, including changing the address for service, limiting or otherwise amending the Statements of Goods and Services, amending the Applications, dividing the Applications and/or withdrawing the Applications.






