NUNC PRO TUNC ASSIGNMENT



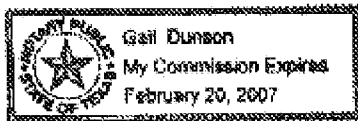
