THIS TRADEMARK ASSIGNMENT AGREEMENT (the "Agreement") effective as of the 31st day of March, 2005, by and between Roger Richman Agency, Inc., a California corporation having a place of business at 9777 Wilshire Blvd. #700 Beverly Hills, CA, 90212 ("ASSIGNOR"), and Corbis Corporation, a Washington corporation having a place of business at 710 Second Avenue, Suite 200, Seattle, Washington, 98104, USA ("ASSIGNEE");

NOW, THEREFORE, ASSIGNOR and ASSIGNEE, in consideration of the mutual agreements herein contained and for other good and valuable consideration, acknowledged by each of them to be satisfactory and adequate, do hereby agree as follows:

Section 1. ASSIGNMENT



1.1. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, ASSIGNOR hereby conveys, transfers, assigns, delivers, and contributes to ASSIGNEE all of ASSIGNOR'S right, title, and interest in and to the Marks, together with (1) the goodwill of the business relating to the Products in respect upon which the Marks used and for which they are registered; (2) all income, royalties, and damages hereafter due or payable to ASSIGNOR with respect to the Marks, including without limitation, damages, and payments for past or future infringements and misappropriations of the Marks; and (3) all rights to sue for past, present, and future infringements or misappropriations of the Marks.

1.2. ASSIGNOR further conveys, transfers, assigns, delivers, and contributes to ASSIGNEE all rights in the trade dress, labels, and designs associated with the Marks.

Section 2. FURTHER ASSURANCES

ASSIGNOR further covenants that it will execute all documents, papers, forms, and authorizations and take all other actions that may be necessary for securing, completing, or vesting in ASSIGNEE full right, title, and interest in the Marks.
