THIS TRADEMARK ASSIGNMENT AGREEMENT (the "Agreement") made as of the 22nd day of August, 2005, by and between Corbis-Bettmann, LLC, a Washington limited liability company, having a place of business at 902 Broadway, New York, NY, 10010, USA ("ASSIGNOR"), and Corbis Corporation, a Washington corporation ("ASSIGNEE"), having a place of business at 710 Second Avenue, Suite 200, Seattle, Washington, 98104, USA;

WHEREAS, ASSIGNOR is the owner of the trademarks and any and all trade dress associated therewith ("the Marks") as described in Exhibit A attached hereto and incorporated by reference herein, together with the goodwill of the business symbolized thereby in connection with the products and services on which the Marks are used ("the Products"); and

WHEREAS, ASSIGNOR desires to convey, transfer, assign, deliver, and contribute to ASSIGNEE all of its right, title, and interest in and to the Marks worldwide (the "Marks").

NOW, THEREFORE, ASSIGNOR and ASSIGNEE, in consideration of the mutual agreements herein contained and for other good and valuable consideration, acknowledged by each of them to be satisfactory and adequate, do hereby agree as follows:

Section 1. ASSIGNMENT

1.1. For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, ASSIGNOR hereby conveys, transfers, assigns, delivers, and contributes to ASSIGNEE all of ASSIGNOR'S right, title, and interest in and to the Marks, together with (1) the goodwill of the business relating to the Products in respect upon which the Marks used and for which they are registered; (2) all income, royalties, and damages hereafter due or payable to ASSIGNOR with respect to the Marks, including without limitation, damages, and payments for past or future infringements and misappropriations of the Marks; and (3) all rights to sue for past, present, and future infringements or misappropriations of the Marks.

1.2. ASSIGNOR further conveys, transfers, assigns, delivers, and contributes to ASSIGNEE all rights in the trade dress, labels, and designs associated with the Marks.

Section 2. FURTHER ASSURANCES

ASSIGNOR further covenants that it will execute all documents, papers, forms, and authorizations and take all other actions that may be necessary for securing, completing, or vesting in ASSIGNEE full right, title, and interest in the Marks.

IN WITNESS WHEREOF, the parties hereto have duly executed under seal and delivered this Agreement, as of the day and year first above written.


