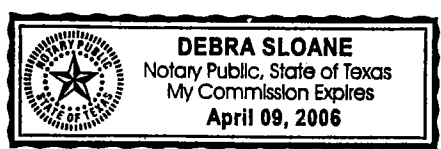
This Assignment is binding on Assignor and its successors and assigns and shall inure to the benefit of Assignee and its successors and assigns and is effective as of January 3, 2000.
