TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (this "Agreement"), effective as of May 30, 2005, is made by and between CHS Inc., a Minnesota corporation ("Assignor"), and GRUMA CORPORATION, a Nevada corporation ("Assignee").

WITNESSETH:

WHEREAS, Assignor has adopted and used, and has registered or applied to register the trademarks and service marks set forth on Exhibit A (the "Marks");

WHEREAS, Assignor and Assignee are parties to that certain Asset Purchase Agreement entered into effective as of May 30, 2005, under which the portion of Assignor's business to which the Marks pertain was transferred to Assignee;

WHEREAS, Assignor has agreed to assign and Assignee has agreed to acquire all of Assignor's right, title, and interest in and to the Marks, both registered and common law, the goodwill of the business symbolized thereby, and the right to recover damages and profits for past infringement thereof; and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. Assignor hereby assigns, transfers and conveys unto Assignee, all of Assignor's right, title and interest in and to the Marks, both registered and common law, the goodwill of the business symbolized thereby, and the right to recover damages and profits for past infringement thereof.
2. Pursuant to that certain Asset Purchase Agreement dated May 30, 2005, Assignor has assigned, transferred and conveyed unto Assignee, all of Assignor's right, title and interest in and to the portion of the business of Assignor to which the Marks pertain.
3. This Agreement shall be governed by and construed in accordance with the laws of the United States of America and of the State of Texas.




